#### **Parent Notifications**

As required by Every Student Succeeds Act (ESSA), the following information is annually shared with parents. The distribution of this document shall serve as a formal notification to parents regarding the following issues:

#### **Right to Request Information**



#### Seminole Elementary Parent & Family Engagement Plan Summary

In support of strengthening student academic achievement, Seminole Elementary School receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement plan that contains information required by Section 1116 of the Every Student Succeeds Act (ESSA). ## **Family Engagement**

Seminole Elementary will involve parents by way of the SAC, PTO, the Family Engagement Committee (FE) and the newly formulated Migrant Parent University (MPU). These programs will be responsible for planning, reviewing, and improving the Title 1 program, family engagement initiatives and funding input and approval for Title I and student incentives. Their peers will elect SAC faculty members. The Principal will choose one grade-level representative from each grade to serve on the Family Engagement Committee. At Open House in August and prior to September 30th, an open invitation will be extended to parents encouraging participation in the SAC, PTO, the Family Engagement Committee and the Migrant Parent University. Documentation of parent input will include meeting agendas, minutes and sign-in sheets. All communication will be done in dual languages to increase parent participation. Translation services will be provided at all SAC, PTO, Family Engagement, and Parent University Meetings.

#### **Parent Meetings**

Seminole Elementary will provide flexible days, convenient morning and evening times, translation services, and support staff as needed for all meetings, activities and conferences to ensure maximum family engagement.

#### **Supporting Partnerships**

Seminole Elementary will build the capacity for strong family engagement by implementing the APTT program. This program and others are designed to support children's academic goals by linking home and school learning. Seminole will also implement Migrant Parent University Workshops and PTO activities.

#### Other Activities

Seminole Elementary will provide literacy & curriculum nights in the fall and spring presented collaboratively by the Reading Coach, teachers, support staff, and administration.

#### **Communication**

Seminole Elementary will ensure and monitor that all information, to the extent feasible, is provided to parents in dual languages. Bilingual staff are also available to provide onsite translation services as needed.

#### **Full Participation in all School Activities**

Seminole Elementary will provide meetings/trainings at different times/days to provide flexible hours for parents whose barrier is time. The Family Engagement Team will provide translators for parents who have disabilities or for those who speak a different language. We will keep the parents informed with teachers' weekly newsletters and administrator's monthly newsletters. Attendance, assessments, and student achievement (grades) will be available through Skyward Parent Portal. Access to a computer will be available at school office and county library. During the Title I, annual meeting parents and Family Engagement team will review the Title I program requirements, Title I funding, and review prior year parent survey results to make suggestions.
